HOMESTEAD REMINDER

If you have not completed your homestead application for the year. You should complete it now.

To qualify for a homestead, you must:

- Own a property
- Occupy the property as your sole or primary residence
- Be a Minnesota resident

Apply to your county assessor by December 31 to qualify for taxes payable the next year.

You must provide the Social Security Number for:

- All owners who occupy the property
- The spouse of each owner, even if they do not live at the location Once granted homestead classification, you do not need to reapply. The county assessor may at any time ask you to submit an additional application or provide other documentation to verify that you continue to meet the requirements for homestead classification.

HOMESTEAD INSTRUCTIONS

As a courtesy notice, please be aware that once you have moved into your new property, it will be your responsibility to contact the appropriate city/county offices and file for the homestead classification for your property taxes. Failure to apply for your homestead classification in a timely manner could increase your property taxes or cause them to remain at a higher amount if the property is now currently classified as Non-Homestead. Please take with you a copy of the Warranty Deed or Contract for Deed and the Certificate of Real Estate Value (CRV). Some counties have the homestead application available online.
